## A-Team Snow Removal Contract Duties

1. A-Team Snow Removal will clear the driveway area, from the street to a safe distance from vehicles and obstacles.
2. Driveways will be cleared when snow accumulation reaches 4 inches or more, once every 24 hours. Snow is plowed or blown and then stored, at a on-site location. Plow times typically happen in the early morning hours or later evening hours, but are subject to change, dependent of storm conditions.
3. A-Team Snow Removal is insured with a \$1,000,000 general liability insurance policy and we accept responsibility for damages caused by driver error. A-Team Snow Removal is not responsible for unforeseen objects covered by snow. The items may get entangled in snow removal equipment, causing damage to the equipment, for example: garden hoses, children's toys, winter recreation equipment, etc. If these items or similar items get left out in the purposed snow removal area, and incur damage to our equipment, A-Team Snow Removal will charge the shop rate of \$106 per hour, to restore the equipment back into service. These fees will not exceed the amount of the repair. **We are not responsible for superficial gouges and chain marks resulting from normal snow removal operations. We will not repair or pay for the repair of driveways that crush or deteriorate due to water saturation or thin asphalt.**
4. The contracting party is allowed to cancel the contract at any time with a \$50 cancellation fee and \$75 charge per service preformed, these fees will not exceed the price of the contract.
